LOCATION OF UNIT: The Model 7324 Eyewash should be installed in close proximity to potential accident areas. It should be clearly identified, free from obstructions and easy to access.

SUPPLY LINE: The minimum recommended line size is 1/2" IPS with 30-90 psi (2-6 ATM) pressure. Where sediment or mineral content is a problem, an inlet filter is recommended.

PLUMBING CONNECTIONS: Inlet supply is female 1/2" NPT. Waste outlet is 1-1/2" NPT.



3.	Eyewash stream does not meet desired eye level.	3.	a.	Possible blocked flow control, see above solution.	
			b.	Possible non-leveled eyewash assembly.	






