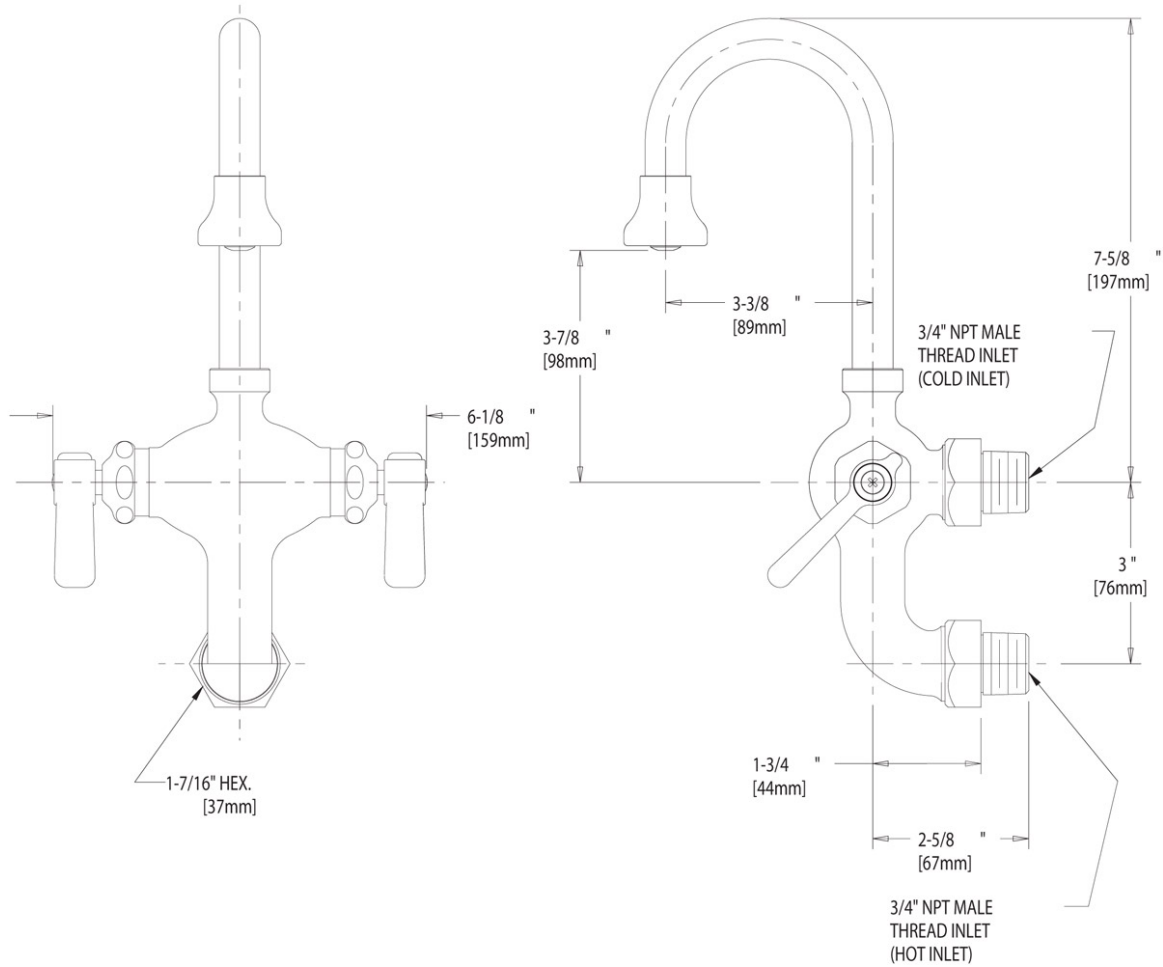

ECAST® construction with less than 0.25% lead content by weighted average. Secondary Control Valve: 3 3/8" Center to Center Rigid Gooseneck Spout. Operation and Maintenance

After installation, remove spout outlet or flow control and flush faucet thoroughly to clear any debris. Care should be taken when cleaning the product. Do not use abrasive cleaners, chemicals or solvents as they can result in surface damage. Use mild soap and warm water for cleaning and protecting the life of Chicago Faucet products.
