Polished chrome-plated brass bubbler head features an integral basin shank for added strength, and is equipped with a shielded, anti-squirt orifice that provides a steady sanitary source of water.

It features a one-piece stamping with a rounded bowl designed for durability and easy maintenance. Fountain valve is installed behind the wall and is to be located in a heated space that maintains a minimum of 50°F temperature to prevent freezing of mechanism.


