## GENERAL

Self-contained, double wall hung electric refrigerated, water cooler. Capacity 8.0 GPH of $50^{\circ} \mathrm{F}$ drinking water, based upon $80^{\circ} \mathrm{F}$ inlet water and $90^{\circ} \mathrm{F}$ ambient.

All models have a hooded stream projector with self closing push bars on front and both right and left sides. Flow regulator provides constant stream from 20 to 105 psi water pressure. Bubbler orifice fully protected to meet all sanitary codes.
NOTE: In special circumstances where both sides of of unit may be used simultaneously it is preferable to install two single filtered units to obtain adequate stream height regardless of pressure. Does not apply to non-refrigerated units.

Pressurized stainless steel evaporator/storage tank for long life. Waterways are certified NSF/ANSI 61, far exceeding the requirements of the Safe Drinking Water Act. Stainless steel water tank is located after bubbler valve, so that the tank is subject to line pressure only when push bar is pressed.

## ADA COMPLIANT

These Water Coolers comply with the requirements of A.D.A. (Americans with Disabilities Act) when properly installed. Also meets the guidelines for children's environments providing the floor to orifice height is 30 " or less and proper clear floor space is provided for parallel approach. (Based on Architectural and Transportation Barriers Compliance Board final ruling.) Check Local and State Codes.

## NO LEAD DESIGN

These Water Coolers are certified to be lead-free as defined by the Safe Drinking Water Act. Elkay Water Coolers are manufactured with a waterway system utilizing copper components and completely lead-free materials. These waterways have no lead because all lead materials, such as leaded brass, have been removed. All joints are brazed using silver solder only. No lead solder is permitted. A strainer with an easily cleanable screen is provided to allow trapping and convenient removal of waterborne particulate of 140 microns and larger prior to their entry into the water cooler.

## WATERSENTRY ${ }^{\ominus}$ VII FILTER SYSTEM

Elkay Water Coolers are equipped with the WaterSentry VII Filter System. Tested to NSF/ANSI Standard 53 yields a reduction of soluble and insoluble lead content to less than $0.015 \mathrm{mg} /$ e. This translates to lead reduction levels of $93 \%$ to $99 \%$. Class 1 particulate reduction as tested per NSF/ANSI 42. Removes over $97.5 \%$ of free available chlorine which provides Class 1 performance as tested to NSF/ANSI 42. Provides taste and odor improvement.

Cabinet: Cabinet design allows for flush to wall mounting. No recess space is required. Includes bottom cover plate fastened with standard screws.

Protected by Elkay's 5 Year Limited Warranty on the refrigeration system of the unit.

If inlet pressure is above $105 \mathrm{psi}(724 \mathrm{KPa})$, a pressure regulator must be installed in the supply line. Any damage caused by reason of connecting this product to supply line pressures lower than $20 \mathrm{psi}(138 \mathrm{KPa})$ or higher than 105 psi ( 724 KPa ) is not covered by the warranty.
